Respected Sir,


1. I have been directed to inform you that All India Defence Civilian Clerk's Association of Army Ordnance Corps (AOC) and the Record Offices through out India apprise your good-self regarding one of the major issue ie "RESTRUCTURING POSTS OF OOC/CSO(Adm)" IN AOC UNDER THE MINISTRY OF DEFENCE who are depriving from the Cadre Restructure since 1972. However, the matter has been projected enumerated with the Department {Ordnance Directorate at Army HQ (OS-8D & OS-20)} for revision/ restructuring the posts of these Officers. But the said case was shuttling in between the Line Directorate and the Ministry of Defence without any cogent reasons except lingering since long with one or the other pretext. Thereafter, this association knocked the door of the Court and the case filed at Hon,ble CAT (Principal Bench) Delhi on June 1st, 2014 in OA NO 2232/2014. Hon,ble CAT gave order on 20 February, 2015 in favour of this association on the part of the Departmental counter's reply of para 13. In his judgment, Hon,ble CAT gave four weeks time (later on four months) to implement the case. Instead of that, the case is still with Ministry of Def {Director (O) } last three and half months as on 18 Jun 2015.
